

Regulation for the title Slovenian Champion - CH SLO

1.

Breed not subject to working trials. To be eligible for the title of Slovenian Beauty Champion, dogs from these breeds must have obtained:

- **4** CAC with at minimum 366 days between the first and the last title (with tolerance of 1-2 days for same week-and shows in different years),
- minimal **2** CAC must be awarded at International shows,
- all 4 CAC must be awarded under different judges

2.

For the dogs who are already Champion of its own country – valid for dog-owners from **(Norway, Sweden, Finland, Denmark, Estonia, Latvia, Lithuania, Russia, Ukraine, Romania, Greece, Israel, Cyprus, Malta, Ireland, United Kingdom, Portugal and Spain)**:

- a) **1** CAC from International show **or**
- b) **2** CAC SLO from National shows

The dog who is not Champion of his own country can use CAC SLO at the moment when the dog will be nominated for Champion of his own country.

3.

Breed subject to working trials. To be eligible for the title of Slovenian Beauty Champion, dogs from these breeds must have obtained:

- **3** CAC with at minimum 366 days between the first and the last title (with tolerance of 1-2 days for same week-and shows in different years),
- minimal **2** CAC must be awarded at International shows,
- all CAC must be awarded under different judges,
- minimal **1** CAC must be awarded in Working Class

Regulation for the title Slovenian Youth Champion - CHJ SLO

1.

To be eligible for the title of Slovenian Youth Champion, dogs must have obtained:

- **3** Junior Winner (PRM)
- minimal **1** Junior Winner (PRM) must be awarded at International show,
- all Junior Winner must be awarded under different judges
- Instead of **1** Junior Winner (PRM) can be used **1** CAC from Intermedia Class

2.

For the dogs who are already Champion of its own country – valid for owners from **(Norway, Sweden, Finland, Denmark, Estonia, Latvia, Lithuania, Russia, Ukraine, Romania, Greece, Israel, Cyprus, Malta, Ireland, United Kingdom, Portugal and Spain)**:

- a) **1** Junior Winner (PRM) from International show **or**
- b) **2** Junior Winner (PRM) from National shows

The dog who is not Champion of its own country can become CHJ SLO at moment when the dog will be nominated for Champion of its own country. This championship is not valid for entry into champion class!

Regulation for the title Veteran Champion of Slovenia – CHV SLO

1.

To be eligible for the title of Slovenian Veteran Champion, dogs must have obtained:

- **3** grades Excellent 1 in Veteran class,
- minimal **1** of grades must have been won at International show,
- all grades must be awarded under different judges

2.

For the dogs who are already Champion of its own country – valid for owners from (**Norway, Sweden, Finland, Denmark, Estonia, Latvia, Lithuania, Russia, Ukraine, Romania, Greece, Israel, Cyprus, Malta, Ireland, United Kingdom, Portugal and Spain**):

- **1** grades Excellent 1 at International show in the Veteran Class **or**
- **2** grades Excellent 1 at National shows

The dog who is not Champion of its own country can become CHV SLO at moment when the dog will be nominated for Champion in its own country.

This championship is not valid for entry into champion class!

To obtain one of the titles, following documents have to be sent in Slovenian Kennel Club:

- **the CAC-cards + copies of the judge-reports**
- **copy of the pedigree**
- **25,- Euro for administrative and postage costs (This fee can be reduced to 10 EUR if the dog is registered in the Slovenian stud book and the documents will be sent to an address in Slovenia)**
- **Name and actual adress of the dog-owner**
